Campaign Overview: The Campaign is an incentive program for the following AMD products: Radeon™ RX Vega, Radeon™ RX 580, and Radeon™ RX 570 graphics cards. Advanced Micro Devices, Inc., 2485 Augustine Drive, Santa Clara, CA 95054 USA (“Promoter”), in conjunction with promotional sponsors Rebellion Interactive Ltd (“Rebellion”), Stardock Entertainment (“Stardock”), and Ubisoft Entertainment (“Ubisoft”), will provide a unique coupon code (“Coupon Code”) for download of specified games (“Applications” as set forth in Table B below) with the purchase of a select associated system containing an eligible AMD graphics card (“Eligible System” as defined below and specified in Table B) or an eligible AMD graphics card (“Eligible AMD Product” as defined below and specified in Table B) from a participating retailer, e-tailer, or System Integrator (“SI”) (“Participating Retailer”). NOT ALL RETAILERS OR E-TAILERS ARE PARTICIPATING IN THIS CAMPAIGN FOR ALL PRODUCTS. 1. TIMING

- b. **Purchase Period:** To receive a Coupon Code, Participant must purchase an Eligible AMD Product during Campaign Period from a Participating Retailer.
- c. **Redemption Period:** The Coupon Code must be redeemed no later than **December 31, 2018** to obtain Application downloads after which the Coupon Code is void.

2. HOW TO PARTICIPATE

- a. To receive a Coupon Code, Participant must purchase a qualifying Eligible AMD Product from a Participating Retailer during the Campaign Period.
