

## RULES AND REGULATIONS

Only 26,000 tickets will be sold.

- \$100 each, 3-pack for \$250, 5-pack for \$375, Friends & Family Pack for \$500 (includes 6 – Home Lottery tickets, 15 – 50/50 Add-On® tickets and 5 – Cash Calendar™ Add-On tickets).
- All tickets in a 3-pack, 5-pack or Friends & Family Pack and all Add-Ons in a 5-pack or 15-pack must contain the same name and contact information.
- Tickets must be purchased and mailed within Saskatchewan.
- Only tickets that have been verified as paid for are eligible for the respective draws.
- Must be 18 years of age or older. Tickets cannot be purchased in the name of a minor.

## **Draw Dates and Deadlines**

VIP Prize Deadline: Midnight, April 26, 2019. VIP Prize Draw Date: May 22, 2019.

Bonus Prize Deadline: Midnight, May 10, 2019. Bonus Prize Draw Date: May 22, 2019.

Early Bird Prize Deadline: Midnight, June 7, 2019. Early Bird Prize Draw Date: June 19, 2019.\* Early Bird Prize Winner Announcement: June 21, 2019.

Final Deadline: Midnight, June 21, 2019. Final Draw Date: July 3, 2019.\*\* Grand Prize & 50/50 Add-On Winner Announcements: July 5, 2019.

Only tickets purchased before midnight, April 26, 2019, will be eligible to win the VIP prize. Only tickets purchased before midnight, May 10, 2019, will be eligible to win the Bonus prize.

\*Only tickets purchased before the Early Bird ticket sales deadline of midnight, June 7, 2019, will be eligible to win the Early Bird prize. If all tickets are sold by the Early Bird ticket sales deadline, then all prize draws, as well as 50/50 and Cash Calendar Add-On draws, will commence at 8:30am on June 19, 2019. The top prize winners will be announced on June 21, 2019.

\*\*If tickets remain after the Early Bird ticket sales deadline, then only the Early Bird draw will be made on June 19, 2019. The remaining prize draws, including the 50/50 and Cash Calendar Add-On draws, will commence at 8:30am on July 3, 2019. The top prize winners will be announced on July 5, 2019. Final ticket sales deadline is midnight, June 21, 2019.

## **Draw Order and Procedure**

The first draw is for the VIP prize followed by the Bonus prize draw on Wednesday, May 22, 2019. The next draw is for the Early Bird prize; then draws are made in the order of the ascending retail value, beginning with the prizes of least retail value.

After each draw, including the VIP, Bonus and Early Bird draws, the winning ticket number is recorded and the ticket number is eligible for subsequent draws. Each ticket purchased before the VIP ticket sales deadline is eligible for 30 prizes. Each ticket purchased after the VIP ticket sales deadline but before the Bonus ticket sales deadline is eligible for 29 prizes. Each ticket purchased after the Bonus ticket sales deadline but before the Early Bird ticket sales deadline is eligible for 28 prizes. Tickets purchased after the Early Bird ticket sales deadline will be eligible for the remaining 27 prizes. All draws will be held at the offices of Ernst & Young LLP. The top valued prize draws may be televised from the Grand Prize Showhome.

Prize draws follow a strict set of procedures, with draw control oversight by Ernst & Young LLP and under licensing approval by the licensing body, Saskatchewan Liquor and Gaming Authority (SLGA).

Each prize draw will select one (1) winner at random. All draws are open to ticket holders. The draws will be completed using Random Number Generator (RNG).

A draw will only be deemed valid and complete upon final confirmation and recording by Ernst & Young LLP.

† 50/50 Add-On and Cash Calendar Add-On tickets must be ordered in conjunction with your Kinsmen Home Lottery ticket(s). 50/50 Add-On and Cash Calendar Add-On orders will not be accepted after your original Kinsmen Home Lottery ticket order date.

A maximum of 200,000 50/50 Add-On tickets are available for purchase. The winner will be awarded half the jackpot up to a maximum of \$423,500. There are 31 prizes in the Cash Calendar with a total prize value of \$47,000. A maximum of 22,500 Cash Calendar Add-On tickets are available for purchase. Cash Calendar Add-On winners' information will be posted daily on the lottery website from July 1 to 31, 2019, according to the sequential manner in which they were drawn.

In the event that all tickets are sold by the Early Bird ticket sales deadline of midnight, June 7, 2019, the Add-On draws will take place on June 19, 2019. If tickets remain after the Early Bird ticket sales deadline, the Add-On draws will take place July 3, 2019.

All winners' of prizes will be notified in writing by Ernst & Young LLP as to what they have won and how to claim prizes. All prizes must be accepted as awarded with no cash alternatives available unless otherwise stated. All prizes should be claimed within one (1) year of the applicable draw date. In the event that winners' have not claimed their prizes within that period, and after reasonable attempts have been made to contact that winner (i.e. telephone, mail), then the prize will be submitted to a charity approved by the SLGA.
