## Council Highlights May 9, 2023

Council approved the **2023 Budget Narrative** that details the County's Operating and Capital budget for 2023. The document can be viewed on the County's website 'Governance/Budget/2023'.

Council approved the migration of the current radio infrastructure to the province's **Alberta First Responder Radio Communication System** with an estimated cost to the County of \$255,162. And, that the County support the Town of St. Paul entering into an agreement with Glenbrie Consulting Ltd. to assist in licensing applications for an estimated cost of \$4,320 and, further, that those specific costs are shared regionally between the Town of St. Paul, Town of Elk Point, and the County of St. Paul with the County's cost estimated at \$1,987.

Council approved the request to sponsor the 2023 St. Paul & District Chamber of Commerce **Farmers Day Golf Tournament** on Friday, June 9, 2023 by sending a team to participate and donating a load of gravel, 12.5T x \$18/tonne, to be delivered within the County of St. Paul for the Silent Auction.

Council approved to provide 10 yards of cold mix at a cost of \$762.50 for the **Elk Point Elks #460** campsite at Kehewin Lake.
