



Let's Talk about Grass Clippings & Grasscycling

- ! Leaving the grass clippings on your lawn actually helps with the overall health of your lawn.
- ! Grass clippings on your lawn returns much of the needed moisture and nutrients to the soil.
- ! Grass clippings do not contribute to excess thatch buildup.

What is Grasscycling? Quite simply, it's about grass and recycling. It's a crucial component to the practice of keeping an organic lawn.

**Grasscycling** refers to the practice of leaving your lawn clippings on your lawn when you mow your grass. This is not a new concept, as many people have done this their whole lives.

#### What are the benefits to Grasscycling?

- The obvious one would be the reduction of work. No more raking, bagging, and hauling heavy bags of grass.
- Grass clippings are full of nitrogen, phosphorous and potassium. By leaving the clippings, you can save on buying less of these fertilizers.
- There is less need for watering your lawn as the clippings help keep the moisture in and are full of moisture themselves.

### Will grass clippings left on the lawn lead to thatch

**build-up?** Thatch is a layer of dead plant matter on top of your soil. When the microorganisms in your soil cannot keep up with rapid root and grass growth, thatch build-up can occur. Thatch build-up may be caused by excess watering and too much fertilizer.

What happens to grass clippings that are taken to the Transfer Stations? A 1,000 square feet lawn can produce 200 to 500 pounds of clippings a year. Landfilled grass clippings can take a very long time to decompose. They produce methane gas due to the lack of oxygen vs being allowed to decompose on your lawn. There are special bins for grass clippings at the Ashmont and Mallaig Transfer Stations. The clippings are moved to the Evergreen Landfill where they get buried in a class 2 cell. Residents, however, are allowed to put clippings in any regular bin.

For a healthy lawn try these tips Mow to leave your lawn 3 to 3.5 inches long, mow regularly, mow the lawn with a mulching mower (helpful but not necessary), keep the blade sharp and dry, and mow in alternate directions.
