**Fixed service charges** pay for items such as building insurance, operators' salaries and benefits, and debt payments for the money that the County has borrowed to build the Water Transmission line from Spedden.

**Water supply charges** cover the treated water that the County purchases from the Highway 28/63 Water Commission.

**Water distribution charges** cover the cost of pumping, material and chemicals required to get potable water to your house in a safe manner.

**Wastewater collection charges** (for Ashmont and Mallaig) cover the cost of materials and chemicals required to take wastewater away from your house in a safe manner.

**Capital replacement contribution for water** is contributing to a reserve fund for future replacement and improvements to the water distribution system and water services.

**Capital replacement contribution for wastewater** (for Ashmont and Mallaig) is contributing to a reserve fund for future replacement and improvements to the wastewater collection systems and services.
