**Business Arising from the November 4<sup>th</sup>, 2025 Regular Council Meeting Minutes**

Chairperson Savannah Durocher states that the non-members eviction date is the end of this month? She would like to know which date, Administrator notified Chair and Council that the date is November 30<sup>th</sup> for the non-member to voluntarily vacate the premises if she does not vacate we will have to go back to the courts and ask for an order to proceed with the eviction.

Councillor Leslie Calliou would like to know if the Security both have magnets for their vehicles that identify as Security? Councillor saw one of the security members and he did not have any markers on his vehicle. Administrator notified

Council that yes, magnets were purchased for both Security units and they will be notified to be utilizing when on shift.

Councillor Dwayne Laboucane would like to know if there is an update on the member that was subletting his home? Administrator notified Council that the homeowner spoke with the Housing director and notified that he is still residing in the home, the homeowner to document whom is residing in the home with the homeowner.

Page.3-Councillor Dwayne Laboucane would like to know if the Public Works department has ordered Sand and Salt? Administrator notified Council that yes, it has been ordered.

Page.3-Chairperson Savannah Durocher noticed at the last Food Bank that there was a lot of food provided and that there were a lot of members assisted. Administrator directed the food bank committee after the last Regular Council Meeting to ensure it can be held twice a month by increasing the budget and securing more funds.

Page.3-Councillor Dwayne Laboucane would like to know whom orders the drug test upon an incident? Administrator notified Council that the seriousness nature of the incident would automatically kick in the process for a drug test especially if its one of the sensitive positions such as Public Works, Emergency Services, or any position that works with Children. If there is no time lost, or no major damage a drug test is not required and it would be a write up.

Vice Chair Tyson Brosseau states that if they are not hurt they will go for the drug test immediately and if they are hurt that staff is required to go to the hospital to ensure they are ok, then be tested.

Chairperson Savannah Durocher would like to know if we have the ability to complete the testing on settlement? Administrator stated that no, we do not.

Councillor Leslie Callioux is happy to hear that the Administration is looking into the Food Bank with extra funds for the Food Bank to be held twice a month this is pretty good for the members.

Councillor Leslie Callioux has a question about the Annual General Meeting a question came up about wanting to be included in the budget process.

Administrator Ryck Chalifoux stated that a member sat here for four years and knows the process with the budget and the review process. We attempt to hold evening meetings where the budget can be reviewed with membership.

Councillor Dwayne Laboucane agrees that when that member was on council he did not do his due diligence and meet with membership and review the budget.

Councillor Leslie Callioux asked if the Library Chair needs to send an agreement for the use of the Cultural Centre? Administrator agreed. Councillor Dwayne Laboucane noted that a board meeting will need to take place with the board members of the Library prior to any agreements being made.

Page.10- Bilateral Patient Navigator Position; Councillor Leslie Callioux would like to know if you are an elected official you are able to apply for a job?

Administrator notified Council that It was after the election that she had applied for the job.

Page.10- Concern with water coloring, Councillor Dwayne Laboucane would like it noted to ensure the water trucks are being chlorinated. Administrator speaks on water quality and notified Council that one of the brines were not operating properly and the Water Plant operator is working to remedy the issue as soon as possible.

### **Secretary Treasurer Tania Daniels stepped out of the meeting @ 9:32a.m.**

Discussion on Member's home Chairperson Savannah Durocher stated that she has heard the Home was inspected and the mold remediation will cost around \$36,000.00. Administrator Ryck Chalifoux stated that the council needs to book with housing and have the issues brought up or some explanation to it because it goes way, way back. There was a larger debt and a portion of that debt was written off. A couple of payments were made to it, but we cannot find anything in any of the minutes that state that any of it was to be written off.

I believe there was an agreement with housing at the time for the work that was done. It would have been done under the previous Housing Director when he was here and they wrote off a big significant portion of that debt for the repairs that were done at the time. Whether they were done right or not is up in the air and I think that was kind of why they wrote off some of that debt.

Councillor Dwayne Laboucane agrees with Ryck, we do need to actually sit down and have a housing meeting because there's a lot of issues coming forward.

**Secretary Treasurer Tania Daniels rejoined the meeting @ 9:37a.m.**

Review of calendar to select a date for the Housing Department to meet with Council. The meeting has been scheduled for Monday November 24<sup>th</sup> at 1:00p.m.

Member was telling the Seniors Coordinator that they are getting the Seniors Board back together and once that happens she will be working under the Seniors after April.

Administrator notified Council that there was a Seniors Meeting with only three seniors present, Susanne and Mallory were told that if the Seniors wish to proceed with this process they will be given the option.

The community garden that member speaks to Chairperson Savannah Durocher states that the Healthy Communities Grant would be perfect for this.

Has there been Schedule for Public Works created yet? Administrator has tasked the Public Works with ensuring this is created and implemented. Tania would like to ensure that there is a schedule for the snow removal equipment.

Councillor Leslie Callioux stated that council has mentioned this twice now and we have yet to receive anything? Administrator notified Council that no the maintenance schedule has not been created, he understands what council would like to see and the frustration he has felt the past three weeks, The Public Works Department is quite busy and having a schedule will now limit them to certain areas. Councillor Dwayne Laboucane worked in that department for five years and he as the water truck was breaking trails. Secretary Treasurer Tania Daniels does not want to cause problems for the Public Works Director she knows he's working she doesn't think that if we don't try to change things, things aren't going to change. Councillor Leslie Callioux states that its not just about Public Works Director or the Grader Operator they have a lot of pressure and a lot to do make a list or a schedule but we shouldn't just be picking on them, there are a lot of pieces of equipment and everyone should be held accountable for what they are doing and the job they hold but she thinks together as one we shouldn't be picking on one person. Councillor Dwayne Laboucane states that we are not picking on anyone

Nicole notified Council of the debt that the member currently has with the Fishing Lake Metis Settlement and that the member has been paying \$100.00 a month toward the debt. Housing Director Terry Parenteau explains the process that takes place when a Housing Committee is making their selection with regard to the rental units, they are given all information pertaining to the applicants and the eligibility and it is then left with the Committee to select based off of the information provided. Housing can have a note on members file stating that she requires housing and this debt does not prohibit her in the future with any housing applications that she may have.

Council would like a letter drafted to the member stating that the balance to the Fishing Lake Metis Settlement must be paid and that she will be eligible for New housing or rental units.


