Administrator understands and agrees with Council and suggests adding MSAT as a topic of discussion at the next assembly to address the concerns with the process.

#### South Road Discussion from the Fishing Lake Metis Settlement to Frog Lake Monument

This road was a major concern throughout the holidays there was absolutely no maintenance or snow removal completed on this road by those responsible, Administrator notified Council that throughout the holidays FLMS had reached out to a local contractor to do snow removal on the road as it was a major safety concern for those traveling on the road.

- Member whom will be receiving a new home, was the old home inspected to reflect the need of a new home? Administrator notified Chair that yes, the old home was inspected which led to the previous council approving the new home as the old home is not structurally safe.
- Membership applications for the Fishing Lake Metis Settlement; are we able to ask if those applying have a membership with the MNA? Administrator stated that this is a question for Metis Settlement Land Registry.


